PERSONAL APPEARANCES AND/OR ITEMS REQUIRING COUNCIL APPROVAL/ACTION

At this time, Mayor Pro Tem Houk skipped to Item #10.

Norm Bulaich was present. The cost presented is \$43 per ton and will be taken to the transfer station off Hwy 121 on Minnis Drive in Haltom City. This is a 3-year agreement. Currently we are contracted with Republic at \$48 per ton but that contract is running out.

CM Claridge moved, seconded by CM Rodriguez to approve the contract with Waste Connections. All voted "Aye".

8. CONSIDER APPROVAL OF DELINQUENT TAX COLLECTIONS & 2021 TURNOVER REPORT AS PRESENTED BY COREY FICKES OF LINEBARGER, ATTORNEYS AT LAW.

Corey Fickes was present. Presented is a report from July 1, 2020 to June 30, 2021. Saw a decrease in unpaid property taxes in River Oaks. Corey presented the top 25 2020 delinquent tax accounts.

They are currently working on collecting utility collections.

CM Chisholm moved, seconded by CM Rodriguez to approve the report by Corey Fickes. All voted "Aye".

9. DISCUSSION AND/OR ACTION REGARDING PRESENTATION BY THE FORT WORTH TRANSIT AUTHORITY REGARDING BUS AND MITZ SERVICE IN RIVER OAKS.

Chad Edwards, Steve Montgomery and Deitra Whitmore were present. A presentation was presented of the background, services overview, ridership graph, bus stops, Route 91 changes, new services since 2017 and the next steps to continue to do with the River Oaks City Council. Council mentioned that busses are still going down Roberts Cut Off Road. The bus stops that were installed on Roberts Cut Off have been bagged. FWTA realized a mistake was made by

adding a route on Roberts Cut Off without consulting with the city first. There have been complaints from people using the MITS service about them being stranded. All complaints need to be emailed to Deitra and all complaints are presented to their board.

This item will be tabled.

ORDINANCES/RESOLUTIONS REQUIRING COUNCIL APPROVAL/ACTION:

12. CONSIDER APPROVAL OF RESOLUTION #1060-2021 AUTHORIZING ECONOMIC DEVELOPMENT CORPORATION (EDC) EXPENDITURES FROM THE 2021-2022 FISCAL YEAR BUDGET AS QUALIFIED FOR PROJECTS MORE THAN \$10,000.00; AND PROVIDING AN EFFECTIVE DATE. (SECOND READING)

Mayor Pro Tem Houk moved, seconded by CM Chisholm to approve Resolution #1060-2021 (second reading). All voted "Aye".

13. CONSIDER APPROVAL OF RESOLUTION #1061-2021 ADJUSTING THE RESIDENTIAL SOLID WASTE COLLECTION RATES.

The residential collection rates will increase \$1 from \$25 to \$26 per month.

Mayor Pro Tem Houk moved, seconded by CM Chisholm to approve Resolution #1061-2021. All voted "Aye".

14. CONSIDER APPROVAL OF ORDINANCE #1325-2021 AMENDING ARTICLE 13.03 "WATER SYSTEM", SECTION 13.03.011 "WATER RATES" OF THE RIVER OAKS CODE OF ORDINANCES (2006) AS AMENDED; ADOPTING AND RATIFYING FEES FOR WATER RATES INSIDE AND OUTSIDE THE CITY LIMITS.

The water rates will increase approximately 9.18%. Currently we have a \$137,000 credit on raw water.

CM Chisholm moved, seconded by CM Claridge to approve Ordinance #1325-2021. All voted "Aye".

15. CONSIDER APPROVAL OF ORDINANCE #1326-2021 AMENDING ARTICLE 13.04 "SEWER SYSTEM" SECTION 13.04.013 "SEWER SERVICE RATES", OF THE RIVER OAKS CODE OF ORDINANCES (2006) AS AMENDED; ADOPTING AND RATIFYING SEWER RATES INCORPORATING A RATE INCREASE FOR RESIDENTIAL, COMMERCIAL AND APARTMENT CUSTOMERS INSIDE AND OUTSIDE THE CITY LIMITS.

Thought we were going to see a 17.64% increase from Fort Worth but realized it is a 12.5% increase.

CM Claridge moved, seconded by CM Chisholm to approve Ordinance #1326-2021. All voted "Aye".

OTHER ITEMS FOR DISCUSSION AND/OR ACTION:

16. DISCUSSION AND/OR ACTION ON SUBSTANDARD PROPERTY AT 5901 BLACK OAK LANE.

The carport and one small building have been removed. The currently demolition company did not realize how bad this is. The representative from the demolition company came before the City Council and said that this project would be complete by the end of August 2021 (which is 14 days from the issuance of the demolition permit). The City cannot issue citations on the demolition company but can the property owner or go thru the civil penalty process. The substandard order is against the property owner, not the demolition company. If the city chooses to demolish the buildings, a lien will be placed on the property but since it is homesteaded, the city will never see that money. Mayor and Council ordered a citation be issued to the property owner every day in violation of the substandard order and start issuing them immediately.

Will close on the CO Bonds tomorrow at 12 noon. In process of getting the new accounts set up. In the meantime, the money will go into the General Fund then transfer over to the new accounts.

As of September 1^{st} , there are new polices regarding mental health. Also, any 380 agreements the city has have to be registered with the State Comptroller. Performance agreements are not 380 agreements.

As of June 15th, if a Police Employee or Fire Employee tests positive for COVID and can prove they got it on the job, they will not have to use their own time during quarantine.
