8. ACTION FROM AUGUST 30, 2022 PUBLIC HEARING: CONSIDER APPROVAL OF ORDINANCE #1358-2022 AFFIXING AND LEVYING MUNICIPAL AD VALOREM TAXES ON ALL TAXABLE PROPERTY WITHIN THE CORPORATE LIMITS OF THE CITY OF RIVER OAKS, TEXAS FOR THE FISCAL YEAR BEGINNING OCTOBER 1, 2022 AND ENDING SEPTEMBER 30, 2023 AT THE RATE OF \$0.754168 PER ONE HUNDRED DOLLARS (\$100.00), AND FOR DIRECTING THE ASSESSMENT THEREOF; PROVIDING FOR A DATE ON WHICH SUCH TAXES BECOME DUE AND DELINQUENT TOGETHER WITH PENALTIES AND INTEREST THEREON; PROVIDING FOR PLACE OF PAYMENT; PROVIDING FOR APPROVAL OF THE TAX ROLLS PRESENTED TO THE CITY COUNCIL.

The highest tax rate that can be approved without an election is \$0.754168/\$100 which is the voter approved rate. This tax rate was included in the budget that was adopted last week. If we adopt a \$0.732086/\$100 tax rate, the city will loose \$84,000 in revenues. By adopting the higher rate, the city will have a black budget in two years.

Deputy Police Chief Perkins was contacted by the military base, and they have a program of military men and women who are within a year of getting out of the military, can attend the police academy and they can be recommended to us for hire.

CM Holland moved, seconded by Mayor Pro Tem Chisholm to approve Ordinance #1358-2022 adopting the tax rate of \$0.754168/\$100. CM Holland, Mayor Pro Tem Chisholm, CM Turner and CM Rodriguez voted "Aye". CM Claridge voted "Nay". Motion passed.

ORDINANCES/RESOLUTIONS REQUIRING COUNCIL APPROVAL/ACTION:

Craig Cunningham was present. This seven-year tax note is to help build the clarifier along with Rescue Act funds. If the city receives any money from litigation, that money can be used towards this tax note. The interest rate with Amegy Bank is 3.25%.

CM Claridge moved, seconded by Mayor Pro Tem Chisholm to approve Ordinance #1359-2022 with Amegy Bank. All voted "Aye".

OTHER ITEMS FOR DISCUSSION AND/OR ACTION:

10. CONSIDER APPROVAL TO ISSUE A SPECIAL PERMIT TO ELATE FUND I REGARDING THE DEVELOPMENT AT 5910 BLACK OAK LANE INVOLVING CONSTRUCTION WORK PERFORMED AFTER 10:00 P.M. AND BEFORE 6:00 A.M. THAT IS IN VIOLATION OF ARTICLE 8.03 "NOISE" SPECIFICALLY IN SECTION 8.03.008 "ERECTION, EXCAVATION, DEMOLITION, ETC., OF BUILDINGS AT NIGHT".

Juan Mancera was present. The nuisance ordinance states between the hours of 10 p.m. and 6 a.m., there cannot be any construction noise. The request is on either September 12th or September 13th, concrete trucks will arrive at midnight and start pouring at 1:00 a.m. This project should be complete around noon. There will be 40 concrete trucks and lighting. The neighbors will be notified.

Amy Beck, 904 Gillham-wants to make sure that this is for one day only.

Scott Bretz, 5813 Black Oak-asked if this contractor owns the lot across the street where staging is occurring? PWD Smith-the city has a contractor replacing waterlines and it is their staging area.

Yvonne Shelnutt, 920 Gillham-getting flooded. Sand is built up and got a lot of debris from the flood in the yard. PWD Smith-have been working with an engineer.

CM Claridge moved, seconded by CM Holland to approve a one-day Special Permit to perform work out of normal hours. All voted "Aye".

11. CONSIDER APPROVAL OF REQUEST FROM ELATE FUND I AT 5910 BLACK OAK LANE FOR THE CITY COUNCIL TO WAIVE THE JULY 26^{TH} DECISION NOT TO ISSUE BUILDING PERMITS UNTIL DETENTION POND IS CONCRETED IN ACCORDANCE TO STAFF REQUIREMENTS AND THE ACCEPTANCE OF DEEDING LOT 1X OVER TO THE CITY.

Juan Mancera was present. All utilities are installed. Extra time is needed to concrete the detention pond because of finances. Would like to get 10 homes sold and built, then concrete the detention pond before the 11 house begins. PWD Smith is comfortable with this request. The pond will have a floor and walls protected during this waiting period.

CM Claridge moved, seconded by Mayor Pro Tem Chisholm to waive the July 26, 2022 decision and allow Elate Fund I to go ahead and build 10 homes, then finish the pond, and then permit and start the 11th home. All voted "Aye".
