1. CALL TO ORDER

With a quorum present, President Chisholm called the Regular Called Meeting of the Economic Development Corporation to order at 6:02 p.m. on Monday, September 13, 2021 at River Oaks City Hall, 4900 River Oaks Blvd., River Oaks, Texas 76114.

7. DISCUSSION AND/OR ACTION ON AGREEMENT WITH FORT WORTH TRANSPORTATION AUTHORITY FOR BUS AND PARATRANSIT (MITS) SERVICE EFFECTIVE THROUGH MARCH 27, 2022.

President Chisholm excused himself at 6:08 p.m. for personal reasons.

The Mayor and City Manager met with FWTA about the route change. FWTA decided not to add a route on Roberts Cut Off. As of right now, FWTA is still going down Roberts Cut Off Road. Council can take action to give a 180-day notice to terminate at anytime or in January 2022, council can issue a 60-day notice not to extend the agreement. FWTA will attend tomorrow's night Council Meeting to give their report. Also discussed with FWTA, was the complaints from citizens about the MITS service leaving people stranded.

President Chisholm returned at 6:13 p.m.

It was brought up by a few board members that they feel the bus service is not helping economic development. Was told in the past by Chris Powers that to get business development, the bus service is needed and the younger people want to ride the bus.

Board agreed to wait until after tomorrow night to decide.

8. DISCUSSION AND/OR ACTION ON ECONOMIC DEVELOPMENT AND PERFORMANCE AGREEMENT ON THE DEVELOPMENT AT 4913 OHIO GARDEN ROAD.

CM Gregory spoke with the owner of Nish today and he is reopening by October 1, 2021 with the same business name. Had to close for a little while but did not permanently close. Member Bybee has had a labor shortage in his restaurant business and had to alter his hours. The agreement that Nish signed says "out of business". No action can be taken.
