### 1. CALL TO ORDER

- ECONOMIC DEVELOPMENT REPORT FROM PAUL PAINE-attended NCTCOG meeting regarding the status of the HWY 199 project. HWY 199 is making progress but HWY 183 is not funded yet.
- ENTRANCE SIGN ON ROBERTS CUT OFF RD AT THE NORTHWEST ENTRANCE TO CITY-talked with Council Member Shingleton and showed a map of the lot for the sign. Also talked with the Fort Worth City Manager and he understood also that this land is not marketable. There has to be a sale price of the property according to the attorney.
- AMENDING THE TAX INCREMENT REINVESTMENT ZONE (TIRZ)-Public Hearings will be on Monday with the Planning & Zoning Commission and on Tuesday with the City Council. These Public Hearings will amend the TIRZ Zone adding in the additional 3.81 acres to the current zone.
- LAND USE PLAN & THOROUGHFARE PLANNING-Public Hearings will be on Monday with the Planning & Zoning Commission and on Tuesday with the City Council. These Public Hearings will consider the adoption of the amending Comp Plan with the Master Thoroughfare Map and Future Land Use Map for the commercial cooridor.
