9. DISCUSSION AND/OR ACTION ON TRANSFERRING FUNDS FROM THE DEPOSIT HOLDINGS RESERVE ACCOUNT TO THE ECONOMIC DEVELOPMENT CORPORATION FOR THE PURCHASE OF RETAIL PROPERTY AT 920 ROBERTS CUT OFF ROAD.

The closing date is scheduled for March 18th, 2020. There are enough funds in Texpool and the bank account in EDC to cover this purchase but funds are needed in the account to maintain operations. The City Auditor approved temporarily transferring \$100,000.00 from the Water Deposit Reserve Account in Texpool to the EDC bank account as long as these funds are moved back by the end of the fiscal year.

President Chisholm moved seconded by VP Holland to approve the transferring of \$100,000.00 from the Water Deposit Reserve Account to the EDC bank account. All voted "Aye".
