Member Houk moved, seconded by Member Richardson to approve the Minutes of the March 9, 2020 Regular Called Meeting. All voted "Aye".

7. DISCUSSION AND/OR ACTION CONSIDERING THE PROPOSALS RECEIVED TO MAKE THE STRUCTURE READY FOR LEASE AT 1512 SHENNA BLVD.

This property needs to get ready to rent or possibly put this property up for sale. Flooring bids were received: Alvaro Monsivais \$5,147.15; Bransom Floor Service \$3,066.28; Bransom Floor Service (includes the atomic dust containment system and the oak shoe molding) \$5,688.60. Painting bids were received: TC Construction (labor & material) \$4,425.00; Unknown bidder (labor only) \$2,800.00; Unknown bidder (labor & material) \$4,100.00. Electrical bids were received: Construction & Electric Service (complete re-wire) \$16,890.19; TC Construction (replace plugs and switches) \$\$750.00.

Board agreed to contact the new owner of the church building and see if they would like to purchase the house; and also the board agreed to get more quotes for the repairs. This item will be brought back at the next EDC Meeting.

8. CONSIDER RECOMMENDATION OF APPROVAL ON COMMERCIAL LEASE AGREEMENT AT 920 "E" ROBERTS CUT OFF RD.

James Blake whom was hired by CM Gregory and the EDC Board to manage and lease the commercial strip at 920 Roberts Cut Off Road was present.

Currently all of the units have a month to month agreement. All units have separate HVAC units. Unit #E doesn't feel comfortable about signing a lease that says they are responsible for the HVAC unit which is over 30 years old.

Board agreed to continue a month to month lease with all units and have them all sign a new lease agreement.

9. CONSIDER APPROVAL OF THE 2ND QUARTER FINANCIAL REPORT (JANUARY 1ST-MARCH 31ST, 2020).

CM Gregory reported the beginning balance for the 2nd quarter was \$212,214.19; sales tax for the quarter totaled \$67,915.94; interest from the bank was \$25.13; money transfer for the purchase of 1512 Shenna was \$195,000.00; money transfer for the purchase of 920 Roberts Cut Off Road was \$285,000.00; Chamber of Commerce dues refund was \$200.00; resulting in total revenues of \$548,141.07. Total expenditures for the quarter were \$649,614.35. The beginning balance in TexPool was \$445,862.28 with interest of \$874.72 and withdrawal for the purchase of properties was \$380,000.00 for a total ending balance in TexPool of \$66,737.00. The ending total bank and TexPool balance was \$177,477.91.

VP Holland moved, seconded by Member Bedford to approve the FY 2020 2nd quarter report. All voted "Aye".
