President Houk-years ago, he was looking for a small town for his roof company. This property was purchased in River Oaks because of EDC. He did apply for a BIG Grant, and it was approved. There are some members of the City Council that want to abolish the EDC and he is against it. Need to embrace the small-town feel. There are aging buildings on River Oaks Blvd. Was told by property management people years ago that River Oaks is hard to deal with. The process needs to be streamlined for starting a new business. Wants to recommend Blythe Reaves as the point of contact for new business and she will direct where the people need to go from there. The dentist was told he could not put certain things on that lot. Instead of saying "no", need to try and achieve their goal. We need to sell River Oaks and have a more positive attitude and we need to change the demographics. We need to publicize city activities and make relationships with commercial realtors.

Need to find out from the City Council what EDC's charge is and what is it that EDC wants to accomplish and what is the focus.

Expenses: EDC Salary Reimbursement \$10,000; Sign & Sign Materials \$10,530; Miscellaneous Supplies \$500; 920 RCO Expenses \$10,000; Transit Service \$27,000; Other Professional Service \$15,000; Legal \$5,000; Travel & Training \$1,000; Dues and Memberships \$200; Property Incentives/Businesses \$35,000; Banners \$5,000; City Promotional \$8,500.

Total Revenues \$289,200; Total Expenditures \$132,730; leaving a surplus of \$156,470.
