6. CONSIDER APPROVAL OF MINUTES FROM THE MAY 10, 2021 REGULAR CALLED MEETING.

Member Richardson moved, seconded by Member Bybee to approve the Minutes of the May 10, 2021 Regular Called Meeting. All voted "Aye".

7. STATEMENT OF APPOINTED OFFICIAL AND OATH OF OFFICE FOR TERM YEAR 2021 APPOINTEES.

CM Gregory gave the Statement of Appointed Official and Oath of Office to Charles Richardson, David Bedford, Darren Houk and Greg Hendrickson.

8. ELECTION OF PRESIDENT & VICE-PRESIDENT FOR TERM YEAR 2021-2022.

Member Hendrickson moved, seconded by Member Bedford to re-elect Dan Chisholm as President and Steve Holland as Vice-President. All voted "Aye".

9. DISCUSSION AND/OR ACTION REGARDING REAL PROPERTY LOCATED AT 1512 SHENNA BLVD.

This property was sold and closed on June 30, 2021 in the amount of \$201,235.16 which is \$210,000.00 minus property taxes. We may be getting a refund of a portion of property taxes once the 2021 Tax Rates are set.

10. DISCUSSION AND/OR ACTION ON AGREEMENT WITH POST OAK MEDIA ABOUT THE DIRECTORY/NEWCOMERS GUIDE FOR RIVER OAKS.

Finally received an email from Post Oak Media. No more ads have been sold. Because there were not enough ads sold, EDC can pay \$3,100.00 for the remaining unsold ads or they can refund the ads that were sold and cancel the contract.

President Chisholm moved, seconded by Member Houk to rescind the contract with Post Oak Media and have Post Oak Media refund the funds to the ones that bought ads. All voted "Aye".

11. CONSIDER APPROVAL OF THE 3RD QUARTER FINANCIAL REPORT (APRIL 1-JUNE 20, 2021).

CM Gregory reported the beginning balance for the 3rd quarter was \$127,817.15; sales tax for the quarter totaled \$61,742.31; interest from the bank was \$19.17; rental income from 920 Roberts Cut Off was \$3,614.08; sale of 1512 Shenna was \$201,235.16; fireworks donation was \$2,250.00; resulting in total revenues and beginning balance of \$166,853.36. Total expenditures for the quarter were \$269,260.72. The beginning balance in TexPool was \$66,846.90 with interest of \$2.13 for a total ending balance in TexPool of \$66,849.03. The ending total bank and TexPool balance was \$451,784.84.

VP Holland moved, seconded by Member Hendrickson to approve the FY 2021 3rd quarter report. All voted "Aye".

- 12. STAFF REPORTS: EXECUTIVE DIRECTOR REPORT
- -Grump's Burgers: they have now closed on both properties and wants to open in November. The platting and site plan approval are complete.
- -Joly Dreams: still waiting on TXDOT approval. Afterwards, will need site plan approval to proceed with construction.

-2621 Jacksboro Hwy: construction is complete. Yummy Donuts opened this past Friday. There are 3 spaces of the 4 leased but they will not open until August 1st. President Chisholm would like to see a ribbon cutting event for Yummy Donuts.

-there is a re-zoning request for a 24-housing addition on the end of Black Oak Lane.

13. WORKSHOP: FY 2022 BUDGET PROPOSAL

PW Superintendent Bell presented a sample street sign with our logo on it and the block number of the street. The ones we have our outdated and do not meet code and are not as visible. The cost of one sign is \$38.50. Would like to start by replacing the ones on River Oaks Blvd and on Roberts Cut Off Road. Eventually, the goal is to replace all street signs in River Oaks. We have received another quote, but it is significantly higher that this one. Our staff would do the installation. President Chisholm feels more comfortable using EDC funds for the signs along River Oaks Blvd. CM Gregory mentioned it is solely up to the EDC to fund all the signs in River Oaks or just parts of it.

CM Gregory presented the proposed budget: Revenues: sales tax of \$225,000.00, interest of \$200.00 and 920 Roberts Cut Off income of \$15,600.00. Expenditures: promotional supplies of \$5,000.00, miscellaneous supplies of \$500.00, 920 Roberts Cut Off expensed of \$10,000.00, transit service of \$24,000.00, other professional services (TIRZ and consultant) of \$15,000.00, legal of \$5,000.00, travel and training of \$1,000.00, dues and memberships of \$200.00, property incentives of \$110,000.00 (\$15k NISH, \$75k Grump's and \$20k extra), banners of \$5,000.00, and city promotional of \$6,500.00 (\$6k fireworks and \$500 car show). The street signs will be discussed at a later meeting.

President Chisholm moved, seconded by Member Hendrickson to schedule the FY 2022 Budget Public Hearing for August 24, 2021. All voted "Aye"
