## **ORDINANCE # 1236-2019**

AN ORDINANCE OF THE CITY OF RIVER OAKS AMENDING THE 2018-2019 FISCAL YEAR GENERAL FUND BUDGET; AND PROVIDING FOR AN EFFECTIVE DATE.

**WHEREAS,** on September 4, 2018 the City Council of the City of River Oaks, Texas approved Ordinance No. 1198-2018, adopting the budget for the fiscal year beginning October 1, 2018 and ending September 30, 2019; and

WHEREAS, it has become necessary for the City to expand the General Fund Budget for the unplanned expenditure associated with the additional asphalt cost in paving the 4400-4600 blocks of Byrd Drive in the amount of \$16,207.00; and

**WHEREAS**, it has also become necessary for the City to expand the General Fund Budget for the unplanned additional expenditure associated with the asphalt overlay in the 5400 Block of Truman; and

**WHEREAS**, the Economic Development Corporation approved the expenditure of \$20,000 for roadway improvements in the 5400 Block of Truman from Gustav east to the 12-foot alley right-of-way and then north to Black Oak Lane; and

WHEREAS, due to material cost increases and weather conditions, the project went over budget by \$6,345.71 and pursuant to the Development Agreement, the EDC by agreement shall pay for the costs of the Municipal Improvements up to but not to exceed \$20,000 and since the costs exceed the \$20,000, EDC has no further obligation; and

**WHEREAS**, because the project couldn't be stopped when it reached \$20,000 and because the project completion was essential in the improvement of a city thoroughfare, the additional cost incurred of \$6,345.71 was approved by EDC to paid out of Account # 03-530-5408 qualified to be an allowable expense for property/business incentives to be paid out of EDC funds and not out of the General Fund; and

**WHEREAS**, with the additional cost incurred of \$6,345.71 for the road improvements in the 5400 Block of Truman Drive being paid out of EDC funds, the amount of \$6,345.71 is hereby deducted and not included in this ordinance amending the 2018-2019 General Fund Budget; and

**WHEREAS**, with the additional expense of Byrd Drive road improvements, the 2018-2019 General Fund Budget for Road Repairs would need to be expanded an additional \$16,207.00 to cover the additional costs incurred; and

WHEREAS, the City Council after due and careful consideration qualified the expenditure and deems it necessary to amend the 2018-2019 fiscal year budget by expanding the unappropriated balance of the General Fund an additional \$16,207.00 dollars in order to offset the unplanned expenditure overage for road improvements in the 4400-4600 blocks of Byrd Dr.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF RIVER OAKS:

## **SECTION 1.**

That the 2018-2019 Budget of the City of River Oaks is hereby amended by an additional \$ 16,207.00 dollars from the unappropriated balance of the **General Fund** and increasing the following accounts as follows:
