ORDINANCE # 1332-2021

AN ORDINANCE OF THE CITY OF RIVER OAKS AMENDING THE 2021-2022 FISCAL YEAR GENERAL FUND BUDGET BY TRANSFERRING REVENUES FROM THE INTERLOCAL AGENCY AGREEMENT WITH CASTLEBERRY INDEPENDENT SCHOOL DISTRICT TO CRIME CONTROL AND PREVENTION DISTRICT IN ORDER TO OFFSET THE INCREASED COSTS IN ORDER TO ADJUST SALARIES IN THE POLICE DEPARTMENT; AMENDING THE FY 2022 FISCAL YEAR CRIME CONTROL AND PREVENTION DISTRICT BUDGET AS ORIGINALLY ADOPTED ON AUGUST 31, 2021 AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, on August 31, 2021 the City Council of the City of River Oaks, Texas approved Ordinance # 1323-2021, adopting the operating budgets of the City for the fiscal year beginning October 1, 2021 and ending September 30, 2022; and

WHEREAS, the Crime Control and Prevention District (CCPD) was established by approval of the voters in the City of River Oaks for the purpose of assisting the police department with equipment, salaries and other operational expenses in order to better aid the police department to increase police protection for the general public; and

WHEREAS, the Police Chief has recently reported that they are having a difficulty recruiting police officers and, in his research, other agencies are experiencing the same kind of recruitment issues; and

WHEREAS, the Police Chief also reported that the difficulty in hiring officers is not the only problem that he is experiencing but it also includes dispatchers and other police employees; and

WHEREAS, the Police Chief believes that salaries are a huge recruitment tool and based on a recent salary survey, the River Oaks Police Department is one of the lowest paid departments in the area, which compounds the problem in recruiting police employees and also in keeping officers and dispatchers; and

WHEREAS, the City Manager in his research of the city's operational budgets found \$25,000 in revenues from the interlocal police agency agreement with the Castleberry Independent School District (CISD) that is an additional revenue resource that can be transferred into the CCPD since it is an agreement with the CISD Police Department for dispatching and other functions of the River Oaks Police Department that aids CISD for police services within the community; and

WHEREAS, the City Manager has reported that the revenue transfer to CCPD along with the CCPD budget being in the black by \$26,000 would provide sufficient funds to offset the cost of adjusting the police employees salaries an additional \$2,000 annually; and

WHEREAS, the Police Chief is of the opinion that by adjusting the police employees salary will aid in the retention of current employees; and

WHEREAS, the City Council after a thorough research of the budget find that by amending the CCPD as recommended by the City Manager it will provide sufficient enough revenues to offset the expenditure for the police employees salaries and further concur with the Police Chief that it is necessary to adjust salaries in order to help retain employees and as a recruitment tool to hire other officers.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF RIVER OAKS:

SECTION 1.

That the 2021-2022 General Fund Budget of the City of River Oaks is hereby amended by transferring revenues from Account 01-4115 to Account # 06-4371 in the CCPD budget in the amount of \$25,000 and adjusting the following accounts below:
