- 7. Committee Reports
  - Heritage Park The Girl Scouts worked at Heritage Park cleaning flower beds and planting new flowers. A thank you needs to be presented to the Girl Scouts and the River Oaks Lion's Club for supplying the flowers.
  - II. Lion's Triangle The trees need to be trimmed.

- III. Coates Park Needs the weed block covered with mulch. Needs to be treated for stickers and fire ants.
- IV. Wooldridge Park There a no changes at the Skate Park. Retaining wall is still in disrepair. The graffiti has been removed. Mineral Oil was used to remove the graffiti. The BMX Trail is being taken care of. The sign on the top of the hill with the Master Plan needs to be removed.
- V. A video of McGee Park was provided by Joksan Holquin. It showed repairs that had been done and ones that needed to be done. Two nets on the basketball goals need to be replaced. Netting on the fence of the large ballfield needs to be replaced or repaired to keep foul balls in the field.

Need to check with LYSA regarding the scoreboard controls deposit. Will they keep the controls for the scoreboard until the season ends?

The bottom of the fencing needs to be repaired. It was suggested by Jimmy Warriner that rebar and cement be used to repair the fences. He will go to McGee Park to investigate and report back. Is electricity making it to the light in right field, the shed behind the concession stand and also the light in left field that shines on the little field?

## 8. Public Forum:

Status of the Park Board Budget LYSA paid its debt to the City. Dollar donations have only been about 50% for the past two years. The Parks Board should have a member attend the Town Council
