The retaining wall: Public works cleaned the drainage ditch and both coverts, it helped, Storm Water has a master plan that we are waiting on to see how we can permanently repair/fix the retainage wall. As of now we have a good drainage.

<u>McGee Park - Public</u> works is going to have Lone Star install the lights at McGee. The Public Works Director gave the board what we are planning to do and how much it will cost for the repairs and installation of new lights.

<u>Lone Star J.R. Park</u> – the City Engineer is looking into the leveling of this park. The City is in contact with Oncor but we are unsure of the price. This will be brought back to the board once we know. the Sprinklers at this park a no longer working. The black netting around the trees needs to be removed. Public Works is working on this. Lone Star also has

so many stickers, what is the game plan there? There is no water at this park to soak into the soil, so we are keeping it mowed. Board members are wanting to put in some planters that are less maintenance since there is no way of watering on a schedule.
