CS Gregory reported the beginning balance for the 3rd quarter was **\$80,223.54**; sales tax for the quarter totaled **\$47,476.35**; interest from the bank was **\$12.31**; grant money received was **\$15,015.**00 resulting in total revenues of **\$62,503.66**. Total expenditures for the quarter of **\$44,573.67**-yielding an ending balance of **\$98,153.53**.

Member Scott moved, seconded by VP Butler to approve the 3rd quarter report. All voted "Aye".

4. BUDGET WORKSHOP: FY 2019 BUDGET PROPOSAL

Big piece of the proposed budget is the renewal along with an increase in salaries of the police step plan. Year one does not affect the general fund but starting in year two does. There is no new vehicle in this proposal.

Revenues total \$189,600; and expenditures total \$199,902; with a total of \$8,428 in the deficit.

Member Holland moved, seconded by Member Chisholm to call a Public Hearing for August 28, 2018 at 6:00 pm for the FY 2019 Budget. All voted "Aye".
