#### CALL TO ORDER

With a quorum present, Mayor Earwood called the Regular Meeting of the River Oaks City Council to order at 7:00 p.m. on Tuesday, October 08, 2013, at the River Oaks City Hall, 4900 River Oaks Blvd., River Oaks, Texas 76114.

PWD James Hatley led the pledges of allegiance to the United States and the Texas Flags.

4. READING OF PROCLAMATION(S) BY MAYOR PRO TEM:

Mayor Pro Tem Gordon read Proclamation for 30<sup>th</sup> Annual National Night Out, October1, 2013.

# PERSONAL APPEARANCES AND ITEMS REQUIRING COUNCIL APPROVAL/ACTION:

7. CONSIDER APPROVAL OF **RESOLUTION #780-2013** FOR SPECIAL EVENT PERMITTING IN ORDER FOR RIVER OAKS CHRISTIAN CHURCH AT 5613 MEANDERING TO SERVE FOOD FOR THE NEIGHBORHOOD TWICE ANNUALLY.

Ida Doraiswamy stated she is requesting a permit to serve food for the homeless in the neighborhood.

CM Crews asked if it would be an indoor or outdoor event.

She stated they plan to take it an outdoor event if weather permits but they are prepared to move the event indoor if needed.

CS Gregory suggested including the Fall Festival they plan on having in November in Resolution # 780-2013 and he stated that the Resolution included that the applicant contact Police Chief 30 days in advance before event.

Mayor Earwood stated the Fall Festival since it was not posted would have to be considered later.

# CM Crews moved, seconded by CM Butler to approve Resolution #780-2013. All voted "Aye"

8. CONSIDRE APPROVAL OF **RESOLUTION # 781-2013** FOR SPECIAL EVENT PERMITTING IN ORDER FOR ARRELLANO'S EMBROIDERY TO HOLD A FUNDRAISER AT 5153 RIVER OAKS BLVD.

No discussion due to lack of information and no representative present.

9. CONSIDER APPROVAL FOR A.V. CATO ELEMENTARY TO BLOCK BARBARA ROAD BETWEEN ISABEL AND CHURCHILL FOR ITS ANNUAL BOOK PARADE.

Richard Remis represented the request on behalf of AV Cato Elementary to block Barbara Rd between Isabel and Churchill from 8:15 -9:15am in order for them to hold a book parade on October 31, 2013.

Police Chief Carter stated he will work with the school for this event.

# CM Butler moved, seconded by CM Ashton to approve to block Barbara Road between Isabel and Churchill adding that the school will work with the Police Chief. All voted "Aye"

10. DISCUSSION AND/OR ACTION ON AMENDING ORDINANCE NO. 1004-2013 THAT AMENDED ARTICLE 13.02 "UTILITY POLICY" DIVISION 4 "SANITATION COLLECTION POLICY" OF THE RIVER OAKS CODE OF ORDINANCES INCORPORATING SECTION 13.02.113" (8) "CURB-SIDE RECYCLING".

CS Gregory stated that it had been recommended that residents be able to purchase recyclable blue bags at any store where they are sold but the resident must still sign up at the City Hall. He also stated that a bigger bag would be more convenient.

Mayor Earwood stated how recycling would cost the city less money due to less trash loads.

PWD Hatley stated that a town hall meeting will be held at the Community Center Oct 15 at 7pm and everyone is invited.

CS Gregory stated it would be cleaner to repeal Ordinance # 1004-2013 and adopt another ordinance that included the changes. He will bring it back at the next meeting for council consideration.

11. CONSIDER APPROVAL OF RECOMMENDATION FOR PARKS BOARD REGARDING THE REPAIRS TO HERITAGE PARK AS PRESENTED BY CHAIRMAN MAKARWICH.

PWD Hatley presented the estimate from Ingean Construction, Inc to repair Heritage Park for \$2,513.50.

CM Crews asked if by "repairing" they meant replacing the wood with new wood. Mayor Earwood stated that he would like to see a more detailed explanation of the scope of work that will be included in that estimate.

CC Directors Shirley Wheat and Shirley Bloomfield explained that the Haunted House is already taking place but this year to make it different they are expanding it a little more and temporarily blocking the access lane behind the center.

Fire Chief Hawkins was asked if that would be violating maintaining a fire lane and he stated that as long as it is a movable object it's not in violation, a violation would be if something is permanently parked.

CS Gregory asked if they were still doing the hay rides because he included it in the resolution. CC Directors Shirley Wheat and Shirley Bloomfield explained that they decided the hay rides were too dangerous but would like to get approval for Carnival Rides from an outside vendor to bring in about four rides possibly for the Christmas Parade and Winter Festival. They explained that Carnival Rides would be a lot of work for just a day and would like approval for it to stay up for three or four days.

Mayor Earwood stated that Carnival Rides would be a great activity for Spring Break.

CC Directors explained that so far they have ten registered for the Christmas Parade.

Mayor Earwood asked how long TXDot requires in advance for permitting to block the highway. Police Chief Carter stated it takes about a week.

It was stated that the parade for this year would be go on as planned.

CM Crews stated he'd like to set a Budget Meeting before 2013 was over. CS Gregory stated that as of Nov 24<sup>th</sup> he'd be out for wife's surgery. A tentative date is set for November 23<sup>rd</sup> at 8:00 am.
