With a quorum present, Mayor Earwood called the Regular Meeting of the River Oaks City Council to order at 7:00 p.m. on Tuesday, September 10, 2013, at the River Oaks City Hall, 4900 River Oaks Blvd., River Oaks, Texas 76114.

CM Crews pointed out two corrections needed to be made to the Council Meeting Minutes from August 27, 2013; on page 2, replace Mayor Pro Tem Crews with CM Crews and update the date on the header of each page.

CM Crews moved, seconded by CM Butler to approve consent agenda items A and B with a couple of corrections on A. All voted "Aye"

# PERSONAL APPEARANCES AND ITEMS REQUIRING COUNCIL APPROVAL/ACTION:

7. DISCUSSION AND/OR ACTION REGARDING THE STANDARD AND POOR GENERAL OBLIGATION FINANCIAL RATING REPORT AS BEING PRESENTED BY CRAIG CUNNINGHAM OF WELLS AND NELSON.

Mr. Cunningham congratulated the City of River Oaks for the rating upgrade. He announced that Standard & Poor's Ratings Services raised its long-term rating on River Oaks, Texas' general obligation debt to AA- from A+.

# No action taken.

8. CONSIDER APPROVAL OF **RESOLUTION #** 776-2013 FOR SPECIAL EVENT PERMITTING IN ORDER FOR ONE FAITH CHURCH TO HOLD A CHURCH HARVEST FESTIVAL.

Pastor Lorenzo Perez presented plans for a Fall Festival which would include music, food and games. If approved it would be held on October 31, 2013 from 6-8:30 pm on the parking lot at 1200 Roberts Cut Off Rd.

Mayor Pro Tem Gordon stated that they would need a health permit from City of Fort Worth Texas for the food service. CM Crews recommended he meet with the Police Chief in regards to parking.

# Mayor Pro Tem Gordon moved, seconded by CM Crews to approve Resolution # 776-2013. All voted "Aye"

9. DISCUSSION AND/OR ACTION ON PLANS FOR CITY CHRISTMAS PARADE EVENT.

Community Center Co-Directors Shirley Bloomfield and Shirley Wheat presented plans for City of River Oaks Christmas Parade 2013. They presented a new route that will start at the new Castleberry Elementary School parking lot and end at the Community Center. Also new this year will include a \$10 participation fee which will benefit needy families in our community. The registration deadline is October 15, 2013 in order for the city to hold the parade.

CM Crews suggested promoting the Parade by posting it on the City Hall Sign. CS Gregory offered to post it on the city web page and will send letter to the church and school to request the use of the parking lots.

Co-Directors also announced that Parker Hannifin will be donating toys to the City of River Oaks to be donated to needy families in our community.

10. CONSIDER APPROVAL FOR CITY TO PARTICIPATE IN THE FORT WORTH CHRISTMAS PARADE.

Community Center Co-Directors Shirley Bloomfield and Shirley Wheat presented plans for the City of River Oaks to participate in the Fort Worth Christmas Parade which will be held Friday November 29, 2013. Registration will cost approximately \$65 and they anticipate about \$300 for expenses.

Mayor Earwood stated it would be a great way to promote River Oaks and to present our new logo.

Mayor Pro Tem Gordon moved, seconded by CM Crews to approve plans for City of River Oaks Christmas Parade as presented and approve the participation in Fort Worth Christmas Parade not to exceed \$400. All voted "Aye"

11. CONSIDER APPROVAL OF CONTRACT WITH FORT WORTH FOR HAZARDOUS WASTE COLLECTION FOR FY 2014.

CS Gregory stated that the cost per household for FY2014 is \$47 per household for waste dropped off at Fort Worth's Environment Collection Center or during a mobile collection event scheduled for our City.

Mayor Pro Tem Gordon moved, seconded by CM Ashton to approve to contract with Fort Worth for Hazardous Waste Collection for FY 2014. All voted "Aye"

12. CONSIDER APPROVAL OF THE FINAL RECONCILATORY CHANGE ORDER ON THE SHEAR STORM WATER DRAINAGE AND PAVEMENT PROJECT.

Project Engineer Michael Thomas stated that the reconciliatory change order is now complete with cost in the amount of \$717.

Mayor Pro Tem Gordon moved, seconded by CM Crews to approve the final reconciliatory change order on the Shear Storm Water Drainage and Pavement Project. All voted "Aye"

# **PUBLIC HEARING / ACTION FROM PUBLIC HEARINGS:**

13. **PUBLIC HEARING:** TO RECEIVE PUBLIC INPUT ON THE PROPOSED 2013-2014 FISCAL YEAR OPERATING BUDGETS FOR THE CITY OF RIVER OAKS.

At 7:44 P.M. Mayor Earwood opened the Administrative hearing.

CS Gregory summarized the expenditures in the General Fund to be \$4,301,940 and projected revenues to be \$4,301,940 for a balanced budget. CS Gregory summarized

the expenditures in the Water Fund to be \$2,825,066 and projected revenues to be \$2,825,066 for a balanced budget.

In the Economic Development Corporation Budget, expenditures to be \$216,850 with \$175,200 in revenues for a deficit budget of \$41,650. CS Gregory stated there were sufficient funds in the Reserve Account to offset the deficit. In Crime District Budget, expenditures to be \$161,433 with revenue projections of \$172,550 for a budget balance in the black by \$11,117. Storm Water Fund has expenditures of \$146,050 and revenues of \$146,050 for a balanced budget.

At 7:53 P.M. Mayor closed the Administrative hearing.

14. ACTION FROM PUBLIC HEARING: CONSIDER APPROVAL OF **ORDINANCE # 993-2013** ADOPTING THE RIVER OAKS OPERATING BUDGETS FOR THE PERIOD OCTOBER 1, 2013 THROUGH SEPTEMBER 30, 2014.

CM Holland moved, seconded by Mayor Pro Tem Gordon to approve Ordinance # 993-2013 adopting the FY 2014 Operating Budgets of the City. All voted "Aye"

15. **PUBLIC HEARING:** CONSIDER APPROVAL OF ADOPTING THE AD VALOREM EFFECTIVE TAX RATE OF \$0.850351 PER \$100 OF PROPERTY VALUE FOR FISCAL YEAR 2013-2014 THAT WOULD IMPOSE THE SAME TOTAL TAXES AS LAST YEAR IN COMPARISON WITH PROPERTIES TAXED IN BOTH YEARS.

At 7:54 P.M. Mayor Earwood opened the Public Hearing.

CS Gregory stated that the proposed tax rate for 2013-2014 is the effective tax rate of \$0.850351 per \$100 which is based on a 2.1 % property value increase from last year. When the value goes up, the effective tax rate goes down and for that reason the 2013 effective tax rate dropped to \$0.850351 from \$0.856519 last year.

An average market value of a home is \$68,444 up from \$67,949 last year therefore the amount of taxes imposed this year on an average home would be \$550.16 at the effective tax rate of \$0.850351.

If the city approves this year's effective tax rate of 0.850351 the projected revenues at a 98% collection rate would be 1.509,412 + 343,526.00 (tax freeze/disability) for a total revenue projection of 1.852.938.

At 7:57 P.M. Mayor Earwood closed the Public Hearing.

16. **ACTION FROM PUBLIC HEARING:** CONSIDER APPROVAL OF **ORDINACE # 994-2013** AFFIXING AND LEVYING MUNICIPAL AD VALOREM TAXES FOR THE FISCAL YEAR BEGINNING OCTOBER 1, 2013 AND ENDING SEPTEMBER 30, 2014 AT A RATE OF \$0.850351 PER \$100 OF PROPERTY VALUE THAT IMPOSES THE SAME TOTAL TAXES AS LAST YEAR IN COMPARISON WITH PROPERTIES TAXED IN BOTH YEARS.

CM Holland moved, seconded by CM Crews to approve Ordinance # 994-2013 adopting the effective tax rate of \$0.850351 for the 2013 tax year. All voted "Aye"

17. **ADMINISTRATIVE HEARING CONTINUED FROM AUGUST 27, 2013:** PURSUANT TO SECTION 3.07.013013 OF THE RIVER OAKS CODE OF ORDINANCES IN ORDER TO ASSESS A CIVIL PENALTY AGAINST THE PROPERTY OWNER AT 809 GUSTAV FOR FAILURE TO COMPLY WITH AN ORDER ISSUED BY THE BOARD PURSUANT TO SECTION 3.07.007 OF THE RIVER OAKS CODE.

At 7:57 P.M. Mayor Earwood opened the Administrative Hearing.

City Attorney Elam stated that the property at 809 Gustav is under the control of HUD and has been since May. At this point beings HUD is a federal agency, the only action available to the council would be to adopt a Resolution imploring them to abate the substandard violations.

At 7:59 P.M. Mayor Earwood closed the Administrative Hearing.

18. **ACTION FROM THE ADMINISTRATIVE HEARING:** CONSIDER ORDERS TO ASSESS A CIVIL PENALTY PURSUANT TO SECTION 3.07.013 AGAINST THE PROPERTY OWNER AT 809 GUSTAV FOR FAILURE TO COMPLYWITH AN ORDER ISSUED BY THE BOARD PURSUANT TO SECTION 3.07.007 OF THE RIVER OAKS CODE OF ORDINANCES.

CM Crews moved, seconded by Mayor Pro Tem Gordon to approve Resolution 778-2013 imploring the U.S. Department of Housing and Urban Development to abate the substandard violations at 809 Gustav. All voted "Aye"

19. **PUBLIC HEARING CONTINUED FROM AUGUST 27, 2013:** SUBSTANDARD ENFORCEMENT ACTION REGARDING STRUCTURE(S) LOCATED ON THE PROPERTY AT **5016 WHITE OAK LANE**.

At 7:59 P.M. Mayor Earwood opened the Public Hearing.

Code Inspector Sanders obtained an Administrative Search Warrant to enter the property and to inspect it as directed at the August 27<sup>th</sup> Public Hearing. He testified that on September 5<sup>th</sup> he entered the property and took the pictures that were presented which show multiple violations. Based on his inspection, the structure is a danger to the health, safety and welfare of any occupants and the general public.

CM Crews stated that the house to be cleaned by the city if owner failed to comply to abate the public nuisance in the allotted time and asked if the house had the potential to be repaired. Code Inspector Sanders stated that it could be repaired, but the owner didn't seem to have the funds.

Neighbor, Calvin Carter testified to have mice infestation. Neighbor, James Ashley testified that the boat parked at 5016 White Oaks Lane has not been moved or used for the past 3 years.

Jack Adkison testified he witnessed about 13 cats at 5016 White Oak Lane property. Mayor Earwood recommends the City to give 10 days for the owner to comply with Code Violations.

At 8:21 P.M. Mayor Earwood closed the Public Hearing.

20. **ACTION FROM PUBLIC HEARING**: CONSIDER COUNCIL ORDER ON THE PROPERTY AT **5016 WHITE OAK LANE** THAT MAY INCLUDE SECURING, VACATING OF OCCUPANTS, REMOVAL, REPAIRING OR DEMOLITION OF STRUCTURE(S) OR ADOPTION OF RESOLUTION IMPLORING A FEDERAL AGENCY TO ABATE ALL SUBSTANDARD VIOLATIONS IN ORDER TO BE BROUGHT INTO COMPLIANCE WITH SECTION 3.07.004 OF THE RIVER OAKS CODE OF ORDINANCES (2006) AS AMENDED.

## CM Crews moved, seconded by CM Butler THAT:

the conditions set forth in the Building Official's Report exist to the extent that life, health, property, or safety of the public (and occupants of the building(s), if applicable) are endangered; and that the structure(s) is/are feasible of repair and therefore moves to order that the Buildings to be repaired BY THE OWNER OF RECORD within 60 days and the LIENHOLDER OR MORTGAGEE OF RECORD to within an additional 30 days if the OWNER does not comply; and the commencement of repairs within 30-days; and the building(s) be repaired in conformance with the requirements of Section 3.07,004 of the River Oaks Code of Ordinances (2006) as amended or demolished by the Owner and the debris removed within 60 days from the date of the public hearing or by the Lienholder or Mortgagee to within an additional 30-days if the Owner does not comply and further find that if the building is not repaired within 60 days from the date of the public hearing, that there is no reasonable probability that the building will be repaired within a reasonable period of time if additional time is given. If the building is not repaired within 60 days or by the Lienholder or Mortgagee of Record, if any, within 90 Days in full conformance with Section 3.07.004 of the River Oaks Code of Ordinances (2006), the building shall be demolished; and Order that substandard fee of \$150.00 be paid upon permit issuance. Certificate of Occupancy will not be finaled until all substandard fees are paid in full. All voted "Aye". Motion Passes.
