1. CALL TO ORDER

With a quorum present, Mayor Earwood called the Regular Meeting of the River Oaks City Council to order at 7:00 p.m. on Tuesday, October 25, 2016 at the River Oaks City Hall, 4900 River Oaks Blvd., River Oaks, Texas 76114.

2. INVOCATION

CM Gordon delivered the Invocation.

PLEDGE OF ALLEGIANCE TO UNITED STATES FLAG AND THE TEXAS FLAG

CM Gordon led the Pledges of Allegiance to the United States and the Texas Flags.

- READING OF PROCLAMATION(S) AND SPECIAL PRESENTATIONS BY MAYOR:

Mayor Earwood read a proclamation declaring October 23 through October 31, 2016 as Red Ribbon Week.

CM Gordon moved, seconded by Mayor Pro Tem Ashton, to approve consent agenda items A, B and C. All voted "Aye."

6. DISCUSSION OR ACTION TAKEN ON ITEMS WITHDRAWN FROM CONSENT AGENDA FOR SEPARATE DELIBERATION.

No discussion occurred and no action was taken.

PERSONAL APPEARANCES AND ITEMS REQUIRING COUNCIL APPROVAL/ACTION:

7. DISCUSSION AND/OR ACTION TO ENTER INTO A 27-MONTH CONTRACT WITH TXU ENERGY ELECTRICAL RATE FOR THE TERM PERIOD OF 3/1/2021-5/31/2023 FOR CITY FACILITIES

Mayor Earwood requested ratification of a 27-month extension of the contract with TXU for electrical usage.

PWD Smith recommended approval to extend the current 33-month contract with TXU for an additional 27 months at .03876 per kWh. PWD Smith mentioned a Greenback program which offers rebates for improvements that reduce kW usage.

Mayor Pro Tem Ashton moved, seconded by CM Scott, to enter into a 27-month contract with TXU Energy and to ratify the Mayor's 27-month contract with TXU Energy for the electrical rate for the term period of 3/1/2021 through 5/31/2023. All voted "Aye."

8. DISCUSSION AND/OR ACTION ON PROGRESS REPORT REGARDING SUBSTANDARD PROPERTY AT 901 CHURCHILL

Thomas Bankston reported that the roof and the foundation repair have been approved by BI Sanders since the last meeting. Mr. Bankston stated his intention to complete the plumbing repairs as the next step.

BI Sanders recommended a 30-day extension with weekly progress checks during which if work stops the order be carried out. Mayor Earwood clarified that the order is to remove the structure.

CM Gordon cited the order which states "significant improvements" which she cautioned need to continue.

Mayor Pro Tem Ashton moved, seconded by CM Scott, to amend the June 28, 2016 order to allow for an additional 30-days for significant progress at 901 Churchill with weekly progress reports to the building inspector with the understanding that if the work stops or does not meet his satisfaction that the existing order currently stands.

Mr. Bankston stated the intention to have the property in full compliance within 2-months.

BI Sanders responded to an inquiry stating that the foundation has been repaired to code and the roof shingles were replaced.

All voted "Aye."

9. DISCUSSION AND/OR ACTION ON SUBSTANDARD BUILDING LOCATED AT 5116 RIVER OAKS BLVD.

An unidentified male representing the property summarized the items completed within the past 90-days as "all of the plumbing and electrical, cleaned the grease trap, and relocated the Knox box." He cited the remaining issues as the rear door and the ventilation for the hot water heater.

BI Sanders confirmed that the building is not off of substandard, stating that the removal of the equipment exposed some open wires, openings on the floor and mold on walls. BI Sanders added that the fire suppression system needs to be inspected and the parking lot needs to be repaired. Mayor Earwood mentioned that the parking lot could be done by the new tenant prior to the issuance of an approved certificate of occupancy. BI Sanders presented pictures of the property in the current state.

CA Elam stated that civil penalties of up to \$1,000 per day could be imposed on the owner following proper notification of a hearing.

The representative requested 30-days to correct the remaining items. The representative was informed of his responsibility to contact the inspections department to schedule weekly progress meetings.

Mayor Pro Tem Ashton moved, seconded by CM Scott, to direct staff to prepare this to bring back for civil penalties in two weeks and that they would be allowed to get permits as needed to address the substandard issues.

The representative stated that they intend to assign the lease to the church on November 1, 2016. CA Elam confirmed that the civil penalties would be assessed against the record owner of the property regardless of the lessee.

Nick Panzera, Victory Church, stated that the church is buying out the lease and previous lessee would be responsible for any penalties levied. CA Elam confirmed that the previous lessee would be named in the order making it a matter between the previous lessee and the owner.

Mayor Earwood cautioned that if the property is not in compliance by November 8, 2016 at 7:00 p.m., civil penalties could be assessed.

All voted "Aye."

At 7:32 p.m. the public hearing was opened.

Louis Lambert, property owner, stated his intention to relocate a personal warehouse and shop which would not be open to the public. Mr. Lambert described the proposal to put the two lots together and build a structure in the middle. Mayor Earwood expressed concern due to the proximity of this location to the school.

At 7:37 p.m. a brief pause occurred while Mayor Earwood stepped away from the dais, leaving the meeting without a quorum.

At 7:38 p.m. Mayor Earwood returned and reconvened the meeting.

After publication and posting review, it was mentioned that the Planning and Zoning Commission recommended re-plat approval, but did not make a recommendation for approval of a non-conforming structure, an amending plat, nor a site plan. CA Elam stated that the zoning administrator could approve an amending plat. CA Elam stated that approval of a site plan requires a recommendation from the Planning and Zoning Commission prior to any action being taken by the City Council.

Staff will approve the amending plat if it meets the requirements and the site plan will go back to the Planning and Zoning Commission and to the City Council.

At 7:49 p.m. the public hearing was closed.

Bill Lohrke recommended the City adopt the proposed water conservation drought contingency plan which is required every five years. The proposal has been updated based on the criteria from the Texas Commission on Environmental Quality, the Water Development Board and in accordance with Region C Planning Group of the Texas Water Development Board and modeled after Tarrant Regional Water District. The new plan list 86 gallons per capita per usage as a way to conserve water. Mr. Lohrke stated that the exhibit may be changed based on growth from 1% to ½%.

CM Scott moved, seconded by Mayor Pro Tem Ashton, to approve Ordinance #1127-2016 revising Article 13.07 Water Conservation and Drought Contingency Plans. All voted "Aye."
