Mayor Pro Tem Holland led the Pledges of Allegiance to the United States and the Texas Flags.

4. WORK SESSION: FUTURE MUNICIPAL PLANNING PERTAINING TO CONSULTANT PETTY AND ASSOCIATES ON CREATING A TAX INCREMENT REINVESTMENT ZONE (TIRZ), CITY CHARTER, EMPLOYEE PERSONNEL POLICY, LAND USE & DEVELOPMENT, SUBDIVISION ORDINANCE, ZONING ORDINANCE PROPOSED AMENDMENTS AND MAY ALSO INVOLVE OTHER AREAS OF MUNICIPAL OPERATIONS INCLUDING BUT IS NOT LIMITED TO ANIMAL CONTROL, BUDGETING, COMMUNITY CENTER OPERATIONS, EMERGENCY MANAGEMENT, FIRE DEPARTMENT, PARKS, POLICE DEPARTMENT, PUBLIC WORKS INFRASTRUCTURE IMPROVEMENTS AND WATER QUALITY.

Mary Petty with Petty and Associates introduced herself and Paul Paine, EDC Consultant introduced himself.

Mary Petty presented a slide show on creating a TIRZ and a TIF which is under Chapter 311 of the Tax Code and only municipalities can create these. Taxes on the increased increment in the

value of property in the zone (over and above the base) are the captured value or "tax increment" used to fund the improvements in the zone. Funding is accomplished by pledging tax revenues that will be realized from increases in property value due in large part from improvements in the district. The term is 20-30 years but the City Council can extend beyond that or can shorten it. The proposed boundaries, project and finance and the next steps that were also talked about.

At 9:15 am, Mayor Earwood excused himself.
