1. CALL TO ORDER

With a quorum present, Mayor Herman Earwood called the Regular Meeting of the River Oaks City Council to order at 7:00 p.m. on Tuesday, February 12, 2019 at the River Oaks City Hall, 4900 River Oaks Blvd., River Oaks, Texas 76114.

2. INVOCATION

Mayor Pro Tem Holland delivered the Invocation.

PLEDGE OF ALLEGIANCE TO UNITED STATES FLAG AND THE TEXAS FLAG

Mayor Pro Tem Holland led the Pledges of Allegiance to the United States and the Texas Flags.

4. READING OF PROCLAMATION(S) AND SPECIAL PRESENTATIONS BY MAYOR:
-PROCLAIMING APRIL 2019 AS RIVER OAKS CLEAN UP MONTH

CS Gregory announced that the Crud Mobile will be at City Hall on March 23rd, 2019 from 9am-11am. There also will be paper shredding and possibly electronic recycling. Tires will not be taken on this day but will be picked up the whole month of April.

Mayor Earwood read a Proclamation designating April 2019 as River Oaks Clean Up Month.

CM Ashton asked everyone to remember Fire Chief's Stockton's family due to a death in the family. CM Chisholm questioned Item #E the Fire Department copy machine.

CM Butler moved, seconded by CM Ashton to approve the Consent Agenda Items #A-H. All voted "Aye".

PERSONAL APPEARANCES AND ITEMS REQUIRING COUNCIL APPROVAL/ACTION:

At this time, Mayor Earwood skipped to Item #12.

A committee was formed which included the Police Chief because the Community Center Directors were having problems with people sneaking alcoholic beverages in by disguise or keeping them in their cars in the parking lot and there is no repercussion if people are found with alcoholic beverages. After much discussion, it was decided to allow alcoholic beverages but there will be two police officers plus a monitor at the rental. The police officers will have to be approved by the Police Chief. The rental deposit for alcoholic beverages will be \$500 plus \$40 an hour per officer per hour with a four hour minimum. The payment to the police officers will be paid directly to them at the beginning of the rental by the person renting the center. If no payment is made, the rental is cancelled. Also, council approval will not be required for alcoholic beverage rentals.

In the draft, the rental fees have changed. For non-residents the rental fee is \$100 per hour and a River Oaks resident rental fee is \$80 an hour with proof of residency with verbiage stating the River Oaks resident has to be on-premises at all times. The rental deposit has increased to \$300 and able to rent the main room and kitchen only. The other rooms will be removed.

Council agreed to have one policy instead of two polices for all rentals (which includes verbiage relating to employees). Also to add Police Reserves as able to rent under the employee policy.

No action taken.

7. CONSIDER APPROVAL OF REQUEST BY LORENDA STEPP TO WAIVE ALCOHOLIC BEVERAGE PROHIBITION IN ORDER TO HAVE ALCOHOLIC BEVERAGES AT HER WEDDING IN THE COMMUNITY CENTER ON OCTOBER 19, 2019.

No one was present and no action taken.

8. CONSIDER APPROVAL TO AWARD CONTRACT FOR TEXAS WATER DEVELOPMENT BOARD PROJECT CWSRF #73749, PHASE II SEWER IMPROVEMENTS AS RECOMMENDED BY THE PROJECT ENGINEER, FROM ALL BIDS RECEIVED AND OPENED AT 1:00 P.M. ON JANUARY 25, 2019 IN THE RIVER OAKS COUNCIL CHAMBERS.

Staff recommended rejecting all bids, to revise bid specs on the footage since more work was done in Phase I, and to rebid.

CM Ashton moved, seconded by CM Chisholm to reject all bids, to re-calculate the footage and to re-bid. All voted "Ave".

9. CONSIDER APPROVAL TO AWARD CONTRACT FOR BYRD STREET PAVING IMPROVEMENTS PROJECT #619-012 AS RECOMMENDED BY THE PROJECT ENGINEER, FROM ALL BIDS RECEIVED AND OPENED AT 11:00 A.M. ON FEBRUARY 8, 2019 IN THE RIVER OAKS COUNCIL CHAMBERS.

Michael Thomas of MJ Thomas Engineering was present. The low bid was Reliable Paving in the amount of \$137,174.40. This project is for curbs, gutters and driveway approaches for 4400-4600 Byrd Drive. The road will be in the CDBG project which has been accepted. Reliable Paving can start immediately with an estimated time frame of completion 60-90 days.

CM Ashton moved, seconded by CM Butler to award the Byrd Street Paving Improvement Project to Reliable Paving in the amount of \$137,174.40. All voted "Aye".

PUBLIC HEARING: IN ORDER TO RECEIVE PUBLIC COMMENT AND TESTIMONY ON THE APPLICATION SUBMITTED BY THE JACKSON LIVING TRUST AMENDING THE EXISTING PROPERTY PLAT PURSUANT TO SECTION 212.016 "AMENDING PLAT" OF THE TEXAS LOCAL GOVERNMENT CODE AND CHAPTER 10 "SUBDIVISIONS" OF THE RIVER OAKS CODE DESCRIBED AS BEING BLOCK 1, LOT 11 OTHERWISE KNOWN AS 5237 PARK DRIVE VACATING 16.67 FEET BY 2.4 FEET OF THE 10 FOOT UTILITY EASEMENT ALONG THE SOUTH PROPERTY LINE PURSUANT TO ORDINANCE #1145-2017 THAT PERMITS A 7 ½ FOOT SECOND SIDE YARD SETBACK ONLY FOR THE PROPERTY LOCATED IN BLOCK 1, LOT 11 OF THE PARK ADDITION. (ZONING CASE #PZ 2019-0001).

At 8:06 p.m., Mayor Earwood opened the Public Hearing.

The request is to amend the preceding plat without vacation of the plat in order to correct an error in a course or distance shown on the preceding plat described as being Block 1, Lot 11 in the Park Addition by moving the south property line 2.4 feet. There is a 10 foot utility easement that has now been vacated by all four utility companies. The Planning & Zoning Commission has approved this request for council recommendation.

At 8:09 p.m., Mayor Earwood closed the Public Hearing.

11. ACTION FROM PUBLIC HEARING: CONSIDER APPROVAL OF THE APPLICATION SUBMITTED BY THE JACKSON LIVING TRUST AMENDING THE EXISTING PROPERTY PLAT PURSUANT TO SECTION 212.016 "AMENDING PLAT" OF THE TEXAS LOCAL GOVERNMENT CODE AND CHAPTER 10 "SUBDIVISIONS" OF THE RIVER OAKS CODE DESCRIBED AS BEING BLOCK 1, LOT 11 OTHERWISE KNOWN AS 5237 PARK DRIVE VACATING 16.67 FEET BY 2.4 FEET OF THE 10 FOOT UTILITY EASEMENT ALONG THE SOUTH PROPERTY LINE PURSUANT TO ORDINANCE #1145-2017 THAT PERMITS A 7 ½ FOOT SECOND SIDE YARD SETBACK ONLY FOR THE PROPERTY LOCATED IN BLOCK 1, LOT 11 OF THE PARK ADDITION. Mayor Pro Tem Holland moved, seconded by CM Ashton to approve the request to amend the plat at 5237 Park Drive. All voted "Aye".

13. CONSIDER APPROVAL TO PURCHASE A NEW I.D. CARD PRINTER, DESIGN SOFTWARE AND DIGITAL CAMERA.

The current machine does not have the capability of meeting all requirements by the state. The Fire Department and Police Department will be splitting the cost. This machine is for the Police and Fire ID badges only.

CM Ashton moved, seconded by CM Houk to approve purchasing a new ID card printer, software and digital camera. All voted "Aye".

14. DISCUSSION AND/OR ACTION ON APPROVAL OF DEVELOPMENT CONSULTING AGREEMENT AS RECOMMENDED BY EDC AT THE FEBRUARY 11, 2019 MEETING WITH PETTY & ASSOCIATES PROVIDING ECONOMIC DEVELOPMENT SERVICES INVOLVING STRATEGIES FOR NEEDS ASSESSMENT, LAND USE PLANNING AND CORRIDOR COMPREHENSIVE PLANNING FOR FUTURE DEVELOPMENT.

Last night, EDC approved the request for council recommendation. Petty & Associates wants to go before the community several times to find out what their needs and wants are.

Mayor Pro Tem Holland moved, seconded by CM Butler to approve the agreement with Petty & Associates. All voted "Aye".
