This is an agreement with the Tarrant County Fire Marshal at no cost.

CM Chisholm moved, seconded by CM Ashton to approve the agreement for Fire and Explosion Investigations. All voted "Aye".

11. CONSIDER APPROVAL OF SERVICE PLAN QUOTE WITH PHYSIO CONTROL, INC. FOR LUCAS-OSCOMP-4 AS PRESENTED BY THE FIRE CHIEF.

This is an annual service agreement on the Lucas chest compression device at a cost of \$1,299.00 for one year.
