### PERSONAL APPEARANCES AND ITEMS REQUIRING COUNCIL APPROVAL/ACTION;

8. CONSIDER APPROVAL OF ORDINANCE #1147-2017 APPROVING A NEGOTIATED SETTLEMENT BETWEEN THE ATMOS CITIES STEERING COMMITTEE ("ACSC") AND ATMOS ENERGY CORP., MID-TEX DIVISION REGARDING THE COMPANY'S 2017 RATE REVIEW MECHANISM FILINGS.

Marilyn Ackmann with Atmos Energy was present. Ms. Ackmann presented the annual rate review. An agreement was reached between Atmos Cities Steering Committee and Atmos Energy Corp. This will result in an approximate \$2.00 rate increase and about a .43 cent customer service charge increase.

CM Holland moved, seconded by CM Scott to approve Ordinance #1147-2017. All voted "Aye".

9. CONSIDER APPROVAL OF REQUEST BY CATHY TRIANA TO WAIVE ADMINISTRATION FEES CHARGED FOR DISCONNECTION OF WATER SERVICE AT 5017 ALMENA DUE TO WATER BILL NOT BEING FORWARDED.

Cathy Triana was not present. CS Gregory said Ms. Triana requested a change of address at the Post Office but they did not forward the water bill to her new address. CM Gordon asked if she provided the city with a new address which she did not. The late fee is \$7.71 and the Administrative Fee is \$25.00. Ms. Triana lives somewhere else and still pays the water bill for that address. CS Gregory recommended her to talk with the Post Office but she did not want to do that.

Mayor Pro Tem Ashton moved, seconded by CM Gordon to deny the request to waive the Administrative Fee and direct staff to contact her to explain the late fee policy. All voted "Aye".

10. CONSIDER APPROVAL OF REQUEST BY DINORAH ROSAS TO WAIVE LIEN ON PROPERTY AT 5025 ALMENA.

Dinorah Rosas was present. Administrative Assistant Maria Tueme was present as a translator. Ms. Rosas has paid the lien in the amount of \$153.37 and is requesting a reimbursement. CS Gregory stated on September 10, 2009, the lien was filed at Tarrant County. Before the lien was filed, notices were sent out to the current owner on record. Ms. Rosas stated she purchased the house in August 2009 and was not informed by the Title Company that there was a lien on the property. Ms. Rosas is currently trying to sell the house and the lien is showing up. That is why she went ahead and paid the lien. CA Elam said the lien was probably filed after Ms. Rosas had closed on the property. Staff went by the Tarrant Appraisal Records when sending out notices.

Mayor Pro Tem Ashton moved, seconded by CM Gordon to approve the request to reimburse the lien in the amount of \$153.37. All voted "Aye".

11. DISCUSSION AND/OR ACTION ON PRESENTATION FROM PWD GORDON SMITH AND BILL LOHRKE OF ES & CM ENGINEERING REGARDING PLANS FOR THE WATER & SEWER SYSTEM IMPROVEMENTS FUNDED WITH CERTIFICATE OF OBLIGATION BONDS.

Bill Lohrke and PWD Gordon Smith were present. Bill Lohrke stated this project started in 2014. PWD Smith presented a slide show (attachment #2). Bill Lohrke stated that plans were sent to TWDB last week. We should have them back by the end of this week with a stamped seal on them. When the construction part of this project starts the city will be on Fort Worth Water for about 3 months and some will notice pressure differences.

12. UPDATE ON STREET ASSESSMENT PROJECT-INVENTORY OF STREETS, COST PROJECTIONS AND ASSESSMENT OF THEIR CONDITION AND WHICH STREETS WILL BE IMPACTED BY THE WATER/SEWER PROJECT AND PROJECTED TIME FRAME.

PWD Gordon Smith presented a slide show (attachment #3).

Community Center Director Wheat said this is the same as last year. Last year the name was Senior Citizens. About 50 people had showed up every Wednesday.

CM Holland moved, seconded by CM Scott to approve the agreement with Sixty and Better of Greater Tarrant County, Inc with a \$1,000.00 commitment. All voted "Aye".

Library Director Veronica Clark was present. This is a one day exhibit awarded to the River Oaks Library from the Tocker Foundation. Volunteers will be available to help with the exhibit.

CM Scott moved, seconded by Mayor Pro Tem Ashton to approve holding the exhibit in the City Hall parking lot on July 19, 2017. All voted "Aye".

15. CONSIDER APPROVAL OF REQUEST TO HOLD A FUNDRAISER TO BE HELD AT 5437 RIVER OAKS BLVD. FOR SANCHEZ TAEKWONDO NATIONAL BOUND STUDENTS FOR THE 2017 NATIONALS IN FORT LAURDEDALE, FLORIDA.

CS Gregory said this was similar to what was done last year. This is a garage sale fundraiser and not for profit.

CM Holland moved, seconded by CM Butler to approve the fundraiser. All voted "Ave".

CM Holland moved, seconded by Mayor Pro Tem Ashton to approve Ordinance #1151-2017. All voted "Aye".
