CALL TO ORDER

With a quorum present, Mayor Earwood called the Regular Meeting of the River Oaks City Council to order at 7:00 p.m. on Tuesday, April 24, 2018 at the River Oaks City Hall, 4900 River Oaks Blvd., River Oaks, Texas 76114.

7. CONSIDER APPROVAL OF RESOLUTION #925-2018 FOR SPECIAL EVENT PERMITTING TO HOLD AN OUTDOOR EVENT AT IRMA MARSH MIDDLE SCHOOL AS PRESENTED BY JASON MARTINEZ OF CISD.

Jason Martinez with CISD was present. This is the 4^{th} Annual Cinco De Mayo Festival at Irma Marsh Middle School that will be held on May 4^{th} , 2018 from 5:30 pm - 7:30 pm.

CM Holland moved, seconded by CM Scott to approve Resolution #925-2018. All voted "Aye".

PUBLIC HEARINGS AND ACTION FROM PUBLIC HEARINGS:

8. PUBLIC HEARING: IN ORDER TO RECEIVE PUBLIC INPUT ON SUBSTANDARD BUIDLING ENFORCEMENT ACTION ON PROPERTY LOCATED AT 621 OAKLAWN AND SPECIFICALLY PERTAINING TO THE STRUCTURE LOCATED ON THE REAR OF THE PROPERTY.

Mayor Earwood opened the Public Hearing at 7:09 pm.

Mark Taylor, son of the owner, was present. Pictures were presented. The rear accessory building was denied by the Zoning Board of Adjustments. This building faces Barbara Road. Mark Taylor lives in the main structure and would like to fix the accessory building up and use it as an office. This building does not meet the required setbacks. If the accessory building is being used as an office, it cannot be detached from the main structure which it is. If the accessory building is demolished and rebuilt, the new building will have to meet the required setbacks.

At 7:29 pm, Mayor Earwood closed the Public Hearing.

9. ACTION FROM PUBLIC HEARING: CONSIDER COUNCIL ORDERS ON THE PROPERTY AT 621 OAKLAWN (REAR STRUCTURE) THAT MAY INCLUDE SECURING, VACATING OF OCCUPANTS, REMOVAL, REPAIRING OR DEMOLITION OF STRUCTURE(S) OR ADOPTION OF RESOLUTION IMPLORING A FEDERAL AGENCY TO ABATE ALL SUBSTANDARD VIOLATIONS IN ORDER TO BE BROUGHT INTO COMPLIANCE WITH SECTION 3.07.004 OF THE RIVER OAKS CODE OF ORDINANCES (2006) AS AMENDED.

CM Butler moved, seconded by CM Chisholm that the City Council finds that the building located at 621 Oaklawn (rear dwelling unit) based on evidence presented at this hearing, is Substandard and: 1) that the conditions set forth in the Building Official's report exist to the extent that the life, health, property, or safety of the public (and occupants of the building(s), if applicable) are endangered; and 2) that the building is infeasible of repair; and therefore order the owner to demolish or remove the building and all debris within 30 days and the lienholder or mortgagee to within an additional 30 days if the owner does not comply; and 3) if the owner fails to demolish or remove the building within 30 days and the lienholder or mortgagee to within an additional 30 days if the owner does not comply, the City shall demolish the building at its expense and place a lien on the property to recover its costs. CM Butler, CM Chisholm, CM Scott, CM Holland voted "Aye". Mayor Pro Tem Ashton voted "Nay". Motion passed.

10. PUBLIC HEARING: IN ORDER TO RECEIVE PUBLIC INPUT ON SUBSTANDARD BUILDING ENFORCEMENT ACTION REGARDING STRUCTURE(S) LOCATED ON THE PROPERTY AT 1101 OXFORD ST.

Mayor Earwood opened the Public Hearing at 7:31 pm.

A substandard checklist and a slide show were presented. The owner is currently in a nursing home and this house has been vacant for about two years. There has been no contact with the estate. The City has been mowing this property for about a year and has been placing mowing liens on the property. There is no mortgagee on this property and the property taxes are current.

At 7:30 pm, Mayor Earwood closed the Public Hearing.

11. ACTION FROM PUBLIC HEARING: CONSIDER COUNCIL ORDERS ON THE PROPERTY AT 1101 OXFORD ST. THAT MAY INCLUDE SECURING, VACATING OF OCCUPANTS, REMOVAL, REPAIRING OR DEMOLITION OF STRUCTURE(S) OR ADOPTION OF RESOLUTION IMPLORING A FEDERAL AGENCY TO ABATE ALL SUBSTANDARD VIOLATIONS IN ORDER TO BE BROUGHT INTO COMPLIANCE WITH SECTION 3.07.004 OF THE RIVER OAKS CODE OF ORDINANCES (2006) AS AMENDED.

Mayor Pro Tem Ashton moved, seconded to CM Butler that the City Council finds that the building located at 1101 Oxford based on evidence presented at the hearing, it Substandard and: 1) that the conditions set forth in the Building Official's report exist to the extent that the life, health, property, or safety of the

public (and occupants of the building(s), if applicable) are endangered; and 2) that the owner has been given an opportunity in the past to make necessary repairs, and there is not reasonable probability that the building(s) will be repaired within a reasonable period of time if additional time is given; and therefore order that the building(s) located at 1101 Oxford be demolished and the debris removed from the property within 30 days and the lienholder or mortgagee to within an additional 30 days if the owner does not comply; and 3) if the owner fails to demolish or remove the building within 30 days and the lienholder or mortgagee to within an additional 30 days if the owner does not comply, the City shall demolish the building at its expense and place a lien on the property to recover its costs. All voted "Aye".

The demolition order will state for them to contact the city within 30 days to remove any personal property.

12. PUBLIC HEARING: IN ORDER TO RECEIVE PUBLIC INPUT ON SUBSTANDARD BUILDING ENFORCEMENT ACTION REGARDING STRUCTURE(S) LOCATED ON THE PROPERTY AT 1617 HILLSIDE DR.

Mayor Earwood opened the Public Hearing at 7:42 pm.

Lisa Catlin, Realtor, whom was contacted by the owner, was present. A slide show was presented. This house has been cleaned out, formally appraised at \$55,000, and is ready to list as a cash purchase only. The yard is being maintained. This house has been vacant since last year.

At 7:57 pm, Mayor Earwood closed the Public Hearing.

13. ACTION FROM PUBLIC HEARING: CONSIDER COUNCIL ORDERS ON THE PROPERTY AT 1617 HILLSIDE DR. THAT MAY INCLUDE SECURING, VACATING OF OCCUPANTS, REMOVAL, REPAIRING OR DEMOLITION OF STRUCTURE(S) OR ADOPTION OF RESOLUTION IMPLORING A FEDERAL AGENCY TO ABATE ALL SUBSTANDARD VIOLATIONS IN ORDER TO BE BROUGHT INTO COMPLIANCE WITH SECTION 3.07.004 OF THE RIVER OAKS CODE OF ORDINANCES (2006) AS AMENDED.

CM Scott moved, seconded by CM Holland that the City Council finds that the building located at 1617 Hillside based on evidence presented at this hearing, is Substandard and: 1) that the conditions set forth in the Building Official's report exist to the extent that the life, health, property, or safety of the public (and occupants of the building(s), if applicable) are endangered; and 2) that the building(s) is/are feasible of repair and therefore order the building to be repaired by the owner within 45 days and the lienholder or mortgagee to within an additional 30 days if the owner does not comply; and 4) the board orders that 30 day progress inspections be made by the City Inspector and be reported to the board prior to the order being reconsidered to be amended and additional time given by the board; and 5) order that the building be repaired in conformance with the requirements of Section 3.07.004 of the River Oaks Code of Ordinances (2006) as amended within 45 days or by the lienholder or mortgagee to within an additional 30 days if the owner does not comply and further find that if the building is not repaired within 45 days, that there is no reasonable probability that the building will

be repaired within a reasonable period of time if additional time is given. If the building is not repaired within 45 days in full conformance with Section 3.07.004 of the River Oaks Code of Ordinances (2006), the building may be demolished; and 6) order that the substandard fee of \$150.00 be paid upon permit issuance. Certificate of Occupancy will not be finaled until all substandard fees are paid in full. All voted "Aye".

The General Fund Projected Revenues collected are 52.03%, and the Expenditures are 48.49%. The Water Sewer Fund Projected Revenues collected are 45.14%, and the Expenditures are 41.62%. We were able to move moneys around in a lot of the departments. Requested is \$49,688.00 in amendments in General Fund and \$28,761.00 in amendments in the Water Sewer Fund.

Mayor Pro Tem Ashton moved, seconded by CM Scott to approve Ordinance #1182-2018. All voted "Aye".

15. CONSIDER APPROVAL OF ORDINANCE #1183-2018 TO TRANSFER FUNDS FROM THE PARK DOLLAR DONATION FUND INTO PARK ACCOUNT #01-524-5198 "CONTRACT LABOR" FOR UNPLANNED EXPENDITURES ON PARK PROPERTY.
