CM Gordon moved, seconded by CM Scott, to approve the consent agenda with a correction in the minutes. All voted "Aye."

11. CONSIDER ADOPTION OF AN ORDINANCE #1141-2017 AUTHORIZING THE ISSUANCE AND SALE OF CITY OF RIVER OAKS, TEXAS COMBINATION TAX AND SURPLUS REVENUE CERTIFICATES OF OBLIGATION, SERIES 2017A, FOR SEWER SYSTEM IMPROVEMENTS; LEVYING AN ANNUAL AD VALOREM TAX AND PROVIDING FOR THE SECURITY FOR AND PAYMENT OF SUCH CERTIFICATES; PROVIDING AN EFFECTIVE DATE; AND AUTHORIZING AND ENACTING OTHER MATTERS AND PROVISIONS RELATING TO THE SUBJECT.

Leroy Grawunder and Craig Cunningham were present. Leroy stated this is a below market interest rate. The proceeds will go to a construction fund. Any monies left over can be used to pay off the certificates or work on other sewer projects. Craig stated the interest rate is established by the Texas Water Development Board which was set last week. There are 30 different interest rates with each year having a different interest rate & principal amount. The net interest will be 1.75% for the sewer over 30 years. Recommend water rate increase or levy tax or a combination of both. CM Holland mentioned the current refunding bonds are not a part of this.

CM Gordon moved, seconded by CM Butler to approve Ordinance #1141-2017. All voted "Aye".

12. CONSIDER ADOPTION OF AN ORDINANCE #1142-2017 AUTHORIZING THE ISSUANCE AND SALE OF CITY OF RIVER OAKS, TEXAS COMBINATION TAX AND SURPLUS REVENUE CERTIFICATES OF OBLIGATION, SERIES 2017B, FOR WATER SYSTEM IMPROVEMENTS; LEVYING AN ANNUAL AD VALOREM TAX AND PROVIDING FOR THE SECURITY FOR AND PAYMENT OF SUCH CERTIFICATES; PROVIDING AN EFFECTIVE DATE; AND AUTHORIZING AND ENACTING OTHER MATTERS AND PROVISIONS RELATING TO THE SUBJECT.

Leroy Grawunder and Craig Cunningham were present. Leroy mentioned this is the water system certificate of obligations. This is the same as the sewer in item #11. Craig stated the net interest rate is 1.875% for water for over 30 years. CM Holland mentioned the city has incurred no debt on the sewer system.

Mayor Pro Tem Ashton moved, seconded by CM Butler to approve Ordinance #1142-2017. All voted "Aye".

13. CONSIDER APPROVAL OF ORDINANCE #1143-2017 AMENDING ARTICLE 13.03 "WATER SYSTEM", SECTION 13.03.011 "WATER RATES" OF THE CITY OF RIVER OAKS CODE OF ORDINANCES (2006) AS AMENDED; ADOPTING AND RATIFYING FEES FOR WATER RATES INSIDE AND OUTSIDE THE CITY LIMITS.

CS Gregory stated this is a recommendation from the Tarrant Regional Water District which is a \$6.63 water rate increase. For a water bill of \$100 this would effectively amount to a 6.63% rate increase on the monthly water bill. CM Holland said this is increasing the base minimum only. Most people are paying more that the base minimum.

There still will be smaller lines to replace in the future. Currently we have the money to pay the remaining balance on the current bond. Craig Cunningham mentioned there are two payments left. One for June 2017 and the other for June 2018. **CM Butler moved, seconded by CM Scott to approve Ordinance #1143-2017. All voted "Aye".**

14. CONSIDER APPROVAL OF ORDINANCE #1144-2017 AMENDING SECTION 13.02.074 OF THE CODE OF ORDINANCES REGARDING FORT WORTH SYSTEM ACCESS FEES FOR WASTEWATER.

CS Gregory stated that Fort Worth came out with a different sewer impact fee schedule. This is a part of our sewer ordinance but a clause is inserted on the impact fees and also inserted are the fees into the schedule. Mayor Pro Tem Ashton mentioned that we do not keep any of the monies collected from Sewer Impact Fees.

Mayor Pro Tem Ashton moved, seconded by CM Gordon to approve Ordinance #1143-2017. All voted "Aye".

15. CONSIDER APPROVAL OF ORDINANCE #1139-2017 AMENDING ARTICLE 4.02 "PEDDLERS, SOLICITORS, AND ITINERANT VENDORS" CHAPTER 2, OF THE RIVER OAKS CODE OF ORDINANCES (2006) AS AMENDED; REPEALING THE FORMER PROVISIONS AND INCOPORATING REVISED PROVISIONS REGARDING PEDDLERS AND SOLICITORS WITHIN THE CITY.

CA Betsy Elam went over the three classifications of the Solicitation Ordinance and the rules (see attached). Rules apply to everyone. Only ones collecting monies (solicitors) have to get a permit. If there is a "no solicitation" sign, no one can come to the door. Also if anyone is asked to leave, they must leave. The Scouts and kids selling candy, etc. the adult in charge of the group must get a permit for the group (not individual kids). If the organization is a 501c or church or politician, they must register but there is no charge for the permit.

Mayor Pro Tem Ashton moved, seconded by CM Gordon to approve Ordinance #1139-2017. All voted "Aye".

16. CONSIDER APPROVAL OF RESOLUTION #890-2017 FOR SPECIAL EVENT PERMITTING IN ORDER TO HOLD AN OUTSIDE EVENT "ALL AMERICAN FESTIVAL" IN THE CITY OF RIVER OAKS ON SATURDAY, JUNE 24, 2017.

Shirley Wheat stated this will be at the old Super Save property. The festival will begin at 7pm.

Mayor Pro Tem Ashton moved, seconded by CM Butler to approve Resolution #890-2017. All voted "Aye".

17. CONSIDER APPROVAL OF RESOLUTION #891-2017 AUTHORIZING CONTINUED PARTICIPATION WITH THE STEERING COMMITTEE OF CITIES SERVED BY ONCOR; AND AUTHORIZING THE PAYMENT OF 11 CENTS PER CAPITA TO THE STEERING COMMITTEE TO FUND REGULATORY AND LEGAL PROCEEDINGS AND ACTIVITIES RELATED TO ONCOR ELECTRIC DELIVERY COMPANY, LLC.

CS Gregory stated this is the standard Resolution like every year.

CM Gordon moved, seconded by Mayor Pro Tem Ashton to approve Resolution #891-2017. All voted "Aye".

The Planning and Zoning Commission voted a 5 to Zero vote to allow the setback to change. CS Gregory said during construction the original survey stakes were pulled up. After the

construction was complete the survey was off by 4" on only one lot. The owner of the property had already paid for the fee and made application.

SOLICITATION ORDINANCE SUMMARY

Three Classifications:

- Canvasser. Personally contacting persons to communicate, orally or by providing leaflets or handbills, for any purpose other than selling, taking orders, or collecting money for any reason.
- Handbill Distributing. Going door-to-door without personally contacting persons to distribute or leave on premises handbills for any reason.
- **Solicitor.** Traveling by foot or vehicle personally contacting persons, whether orally or with written material, for the purpose of selling or taking orders for goods or services or collecting money for any purpose.
- The ordinance imposes rules on canvassers and handbill distributors, but only a solicitor is required to get a permit and register.
- Rules applicable to canvassers, handbillers and solicitors:
 - Prohibited before 9:00 a.m. or after dark or 9:00 p.m., whichever is earlier;
 - May not solicit or canvass if "No Solicitors" sign on door;
 - Must leave if asked to go by owner or tenant;
 - May not be aggressive;
 - Must place handbill within 5 feet of the door;
 - May not leave a handbill if another is already there; and
 - Must place the handbill so it doesn't blow away.
- Rules applicable only to solicitors:
 - Rules for soliciting from vehicles;
 - Must register and obtain a permit;
 - Must obtain a bond if taking orders and funds for products or services to be delivered at a later date; and
 - Special rules for juveniles.
