

## ORDINANCE # 1196-2018

**AN ORDINANCE AMENDING ARTICLE 12.04, "SPEED", SPECIFICALLY IN SECTION 12.04.003 "SPECIAL SPEED ZONES" OF THE CITY OF RIVER OAKS CODE OF ORDINANCES (2006) BY INCORPORATING INTO SECTION 12.04.003 SUBSECTION 12.04.003(d) "INSPIRATION LANE" TO INCLUDE APPROXIMATELY 0.455 MILES OF ROADWAY IN THE 1700—1800 BLOCKS OF INSPIRATION LANE FROM ITS INTERSECTION ON THE SOUTH END AT MILLER STREET AND EXTENDING BACK NORTH TO THE CUL-DE-SAK DEAD END AT THE NORTH END OF INSPIRATION LANE BY DESIGNATING A PRIMA FACIE MAXIMUM REASONABLE AND PRUDENT SPEED OF 25 MILES PER HOUR AS PLOTTED HEREIN ON EXHIBIT "A" OF THIS ORDINANCE AT ALL TIMES; PROVIDING THAT THIS ORDINANCE SHALL BE CUMULATIVE; PROVIDING A SEVERABILITY CLAUSE; PROVIDING A SAVINGS CLAUSE; PROVIDING A PENALTY; PROVIDING FOR PUBLICATION IN THE OFFICIAL NEWSPAPER; AND PROVIDING AN EFFECTIVE DATE.**

**WHEREAS**, the City of River Oaks is a home rule City acting under its Charter adopted by the electorate pursuant to Article XI, Section 5 of the Texas Constitution and Chapter 9 of the Local Government Code; and

**WHEREAS**, following an extensive traffic study performed by the River Oaks Chief of Police, the police Chief recommends establishing a reasonable maximum prima facie speed limit of 25 miles per hour in the 1700 and 1800 blocks of Inspiration Lane; and

**WHEREAS**, the City Council has determined after due and careful consideration that based on the traffic study and recommendation from the Police Chief it is essential to designate and incorporate the 1700 and 1800 blocks of Inspiration Lane as plotted herein on "Exhibit A" of this Ordinance as a maximum prudent speed zone of 25 m.p.h. in order to protect the safety of the children, bike riders and walking pedestrians.

**NOW THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF RIVER OAKS:**

### SECTION 1.

#### **Section 12.04.002 "Specific Locations"**

That Article 12.04, "Speed" of the City of River Oaks Code of Ordinances (2006) with the adoption of this ordinance, Section 12.04.003 "**Specific Speed Zones**" is amended by revising Section 12.04.003 by adding Section 12.04.003(d) establishing the vehicular prima facie speed of 25 miles per hour on Inspiration Lane to now read as follows:

**"(d) Inspiration Lane.** The prima facie maximum reasonable and prudent speed of 25 MPH on Inspiration lane approximately 0.455 miles from Miller Street north to the end of the street at the cul-de-sak effective when appropriate signs giving notice of the limit are erected. These reduced speed limits are enforced between the signs which are erected.

#### **SPEED LIMIT ZONE**

**On Inspiration Lane from its intersection with Miller Street on the South and continuing north from there approximately 0.455 miles in the 1700 and 1800 blocks of Inspiration Lane to the dead end cul-de-sak on the far north end of Inspiration**

**Lane establishing a reasonable maximum prima facie speed limit of 25 miles per hour at all times."**

## **SECTION 2.**

### **CUMULATIVE**

This Ordinance shall be cumulative of all provisions of Ordinances of the city, except where the provisions of this ordinance are in direct conflict with the provisions of such ordinances, in which event the conflicting provisions of such ordinances are hereby repealed.

## **SECTION 3.**

### **SEVERABILITY**

It is hereby declared to be the intentions of the City Council that the phrases, clauses, sentences, paragraphs, and sections of this Ordinance are severable, and if any phrase, clause, sentence, paragraph, or section of this ordinance shall be declared unconstitutional by the valid judgment or decree of any court of competent jurisdiction, such unconstitutionality shall not affect any of the remaining phrases, clauses, sentences, paragraphs and sections of this ordinance, since the same would have been enacted by the City Council without the incorporation in this ordinance of any such unconstitutional phrase, clause, sentence, paragraph or section.

## **SECTION 4.**

### **SAVINGS**

All rights and remedies of the City of River Oaks are expressly saved as to any and all violations of the provisions of the City of River Oaks Code of Ordinances (2006) or any other ordinances affecting prima facie maximum speed limits which have accrued at the time of the effective date of this ordinance; and, as to such accrued violations and all pending litigation, both civil and criminal, whether pending in court or not, under such ordinances, same shall not be affected by this ordinance but may be prosecuted until final disposition by the courts.

## **SECTION 5.**

### **PENALTY**

In accordance to Section 1.01.009, "General penalty for violations of code; continuing violations", of the City of River Oaks Code of Ordinances (2006) as adopted and as amended; whenever in this code or in any ordinance of the city an act is prohibited or is made or declared to be unlawful or an offense or a misdemeanor, or whenever in such code or ordinance the doing of any act is required or the failure to do any act is declared to be unlawful, and no specific penalty is provided therefor, the violation of any such provision of this code or any such ordinance shall be punished by a fine of not exceeding five hundred dollars (\$500.00). Each day any violation of this code or of any ordinance shall continue shall constitute a separate offense.

## **SECTION 6.**

### **PUBLICATION**


The City Secretary of the City of River Oaks is hereby directed to publish in the official newspaper the caption, savings clause, penalty clause, publication clause and effective date clause of this ordinance one (1) time after the adoption of this ordinance as authorized by Chapter 5, Section 5.02(c) of the Charter of the City of River Oaks.

**SECTION 7.**


**EFFECTIVE DATE**
