1. Call to Order:

The meeting was called to order at 6:31 pm by Chairman Makarwich

- 2. Member Roll Call: (Makarwich, Ballard, Ashton, Warriner, Vandiver, Martinez, Limas and Brooks).
- 3. Approve Minutes from February 4, 2016: Chairman Makarwich made the motion to approve the minutes of 2/4/2016. Vice- Chair Ballard seconded the motion. All Aye.
- 4. Report from Council Liaison Joe Ashton: Joe thanked all the Board members for their service to the community.

appointee to oversee the Project at Heritage Park. She will report the details to Chairman Makarwich. The Board members will be invited to the on- site planning of the project.

- b. Shirley knows some citizens that would be interesting in volunteering for the project. She will also speak to Boy Scout Leader, Roger Shaw, as the Boy Scouts may be interested in volunteering.
- c. 1. Shirley mentioned the water feature is not in operating order.
 - 2. The Rose beds are full of weeds.
 - 3. The ground cover is overgrown.
 - 4. Possibility of moving some of the pavers and making a walkway with the pavers. The walkway would lead to the arbor. Moving the paver bricks from around the garden areas would mean less weed-eating...
 - 5. Possibility of planting miniature Crepe Myrtle trees on each side of the arbor.
 - 6. Possibility of placing benches near the large trees.

 Noted that: Marvin will provide Shirley with at least 3 yellow Volunteer vest.
- 6. Consider approval of recommendation by the Parks Board to the City Council as requested by Shirley Wheat in order for the City to be placed on the project list with Lowe's Home Improvements for park improvements.

 - b. Shirley will receive the project information for the Parks Board review.
 - c. The City Council must approve the project.

 - a. City Secretary-Marvin, will check with the Police department to confirm if there has been any recent issues or vandalism.

- c. Erin Carter, VP of RO. LYSA reports that she would also like to form a Special Needs league.
- d. Vice- Chair David Ballard will provide Erin Carter with a copy of the LYSA Contract for review and extension.
- e. ISSUES: The ant hills at both fields need to be treated. Erin also needs a key to the Men's restroom. Marvin stated he would provide the key.
- f. Chairman Makarwich entertained the motion to propose that the current agreement be extended for another year. Vice- Chair, Ballard made the motion to approve the extension of the contract. Warriner seconded the motion. All- Aye.
